1. Call to Order
 - a. Quorum present
2. Approval/additions to Agenda
 - a. move #9 to #5
 - i. Moved accept with change Elmer, second Lee, pass unanimously
3. Approval of Minutes
 - a. Moved Lee, Second Elmer, passed unanimously
4. Citizen's input for items on the agenda—
 - a. Mayor would like to address the Board
 - i. re: "Code of The West"
 1. The mayor explained how the town has adopted "The Code of the West", and read the resolution.
 - ii. The Mayor also had a special request to the Board.
 1. Upon the return of The Grove's, and rebuilding commences, he would like to request the board waive all permit, and deposit fees for the reconstruction of their home, that would not be reimbursed by their insurance company.
 - a. The board expressed they would not have a problem with waiving those fees not reimbursed by their insurance.
5. Action Items:
 - a. 137 Alpen Glow Cir Plat15 Lot38 New single family Residence
 - i. Jody explained only issue was he had red-lined the plans for continuous footings, an issue if the retaining wall was more than 4' high.

1. We had received a letter from Huhtala explaining he didn't feel the retaining wall would not need to be over 4 feet, but if it did, at a later date, he would bring us engineered plans.
- ii. Bob Palmquist brought attention to: now we have a zoning Ordinance, and in the ordinance Chapter 9 there are references to driveways Section 4.39, and outside lighting section 4.41.
 1. It was suggested to add to our permit process checklist these items, to bring to the attention of owners/contractors.
 2. Yolanda was asked to add these items
 3. It was also suggested we add this information to Culver's contingency letter, due to the fact this is the first permit for a house since the change.
- iii. Lee Hansen motioned to issue the Permit with a contingency letter for:
 1. reference to Chapter 9, Zoning Ordinance, Sections: 4.39/4.41
 2. Reference to the retaining wall, if it in fact needs to be over 4' we will need engineered plans for the wall.
- iv. Elmer Beck seconded the motion, Unanimous to issue Permit
