

Title 13 Municipal Court Bond Schedule and Court Appearances

Any person or persons found in violation of any section of the Town Code shall be fined or otherwise penalized in a manner consistent with the Town of Star Valley Ranch Municipal Court Bond Schedule.

The Special Municipal Officer issuing the citation may require mandatory court appearance for the following reasons: 1.) this is a second offense, or a warning has previously been issued, 2.) the offense is of such complexity as to require the judge to resolve the matter, or 3.) the defendant requests a hearing on the charged violation and bond before the judge.
