## Water Improvement Project – 2017: Update

Taylor Construction is currently pressure testing and chlorinating main lines and installing new service lines. As a reminder, these service connections will require a brief shutdown of water to each residence. Door hangers will be left at each affected residence on the timing of these service connections. Additionally, the Town has put out water shutoff signage in various locations and will continue to do so until the last services are installed. Taylor construction is responsible for repairing damages to road surfaces and will begin repair efforts as soon as the service lines are installed so we have satisfactory roads for the winter.

## Optional County-wide 6<sup>th</sup> Penny Tax Vote

If voters support the 6<sup>th</sup> penny tax, the Town will chip seal up to 15.12 miles of road within town boundaries. The funding from the 6<sup>th</sup> penny tax would provide funding to the tune of \$1.2M,

covering almost all of our arterial- and collector-type roads with a double-layered chip seal. This would free up our roads budget, allowing for the paving of around 10 miles of lesser traveled roads.

County-wide, the emphasis is on roads. Around 85% of the Special Purpose Tax (a tax that can only be used for specified projects and projected to end within roughly 3.6 years) will be spent on roads. Lincoln County, which isn't using the funds for paving roads, is still using the funds on equipment (i.e. snow plows, etc.) to better maintain the roads they do have for all citizens.
